Purpose

To offer students a chance to participate in testing a new course and providing feedback in exchange for discounted tuition fees. This program will also help the school to evaluate the effectiveness of the new course and make any necessary changes before offering it to other students.

Eligibility

All incoming students who meet general eligibility requirements as of March 2023 until we have reached 10 testers per location.

Program Details

Students in this program will receive a deeply discounted tuition in exchange for testing the new course and providing feedback.

Discounted Tuition: Our normal pricing of \$9,500 will be discounted to a mere \$2,500 for this program only. Terms and Conditions apply, please see Tuition document.

School will provide:

- Required coursework and training to meet the hours needed according to Indiana state law for massage therapy licensing.
- Continued assistance until student's passes the state MBLEX test.

Students will need to provide:

- Feedback throughout the course on content, activities, etc.
- Patience and understanding as the school make changes to the course.
- Promise to keep information confidential, non-disclose to outside parties, and have a positive mindset about the entire program and school.

Tutor/Instructor Disclosure:

In exchange for discounted tuition fees, the Student agrees to:

- 1. Participate in the new course testing and feedback program and provide honest feedback about the course content, teaching methods, and overall effectiveness of the course.
- 2. Complete all assignments and assessments required by the course and attend all class sessions unless there is a legitimate reason for absence.
- 3. Acknowledge that they have read and understood the 2-Level Certification Course document, which outlines the new course and its objectives.
- 4. Acknowledge that they have read and understood the Tutor/Instructor Disclosure, which outlines the school's plans to utilize tutors trained and overseen by qualified instructors.
- 5. Agree to a non-compete clause, which stipulates that the Student shall not engage in any activities that directly compete with the School in primary education for massage therapy for a period of two years after completing the program.
- 6. Agree to a non-disclosure clause, which stipulates that the Student shall not disclose any confidential information, trade secrets or intellectual property belonging to the School, including but not limited to, course materials, processes, test questions, and student information, to any third party without prior written consent from the School. Any information, feedback or insights obtained through their participation in the new course testing and feedback program shall not be shared for any purpose other than providing feedback to the School.
- 7. Agree to a non-disparagement clause, which stipulates that the Student shall not make any negative or derogatory comments about the School, its employees, officers, or agents, or its programs, to any third party, including on social media, blogs, or other public forums.

The School guarantees that:

1. The Student will receive the agreed-upon discount on tuition fees.

- 2. The School will work with the Student to help them prepare for their MBLEX licensing test.
- 3. The School will take the Student's feedback seriously and make any necessary changes to the course to the best of our ability before offering it to other students.
- 4. The School will meet Indiana state minimum course requirements for certification in massage therapy to obtain license.
